# Family Camp Consent Agreement•

*(Please read, sign and submit)*

## Family Camp information, guidelines and restrictions for all participants:

1. Once **CONFIRMED** registrations are processed on a first-come, first-served basis.
2. A Registration is considered **CONFIRMED** when:
  - a. Non-refundable deposit is received of \$100 per adult
  - b. Signed Family Consent form is received
  - c. Requested lodging is available and secured
3. Please submit your non-refundable deposit and your signed family consent form within two weeks of registering to confirm your registration.
4. You may request Girls or Boys cabin area, or Chi Rho Lodging. Chi Rho lodging has an extra \$125 fee per adult.
5. Unless otherwise specified all communications including the "Confirmation of Registration" are via email.
6. Camp Fowler will provide "tentative schedules", "what to bring list", and other as needed documents directly on the website to be accessed by download. Unless directly requested this information will not be mailed.
7. Non-immediate family member children may attend Family Camp under these conditions:
  - a. Approval from Camp Director
  - b. Non-immediate family member child must be 1 of 3 attending children to 1 paid adult participant.
  - c. Non-immediate family member child must submit an immunization list (NYSDH Requirement) within 2 weeks of approved registration as well as an Over-The-Counter drug release form (not required for attendance).
  - d. Non-member family fee of \$260 must be paid in full prior to attendance.
8. All adult and child participants must be listed on registration application including grade attending and gender.
9. Camp Fowler does not allow any overnight guests. All attendees must be registered in Family Camp.
10. Day Visitor Passes may be issued at the discretion of the Camp Director under the following conditions:
  - a. Approval from the director
  - b. Visitor must check-in and check-out with Camp office staff.
  - c. Visitor must visibly wear a day pass (issued at check-in and returned at check-out) at all times.
  - d. Day Pass fee is \$50 per person and must be paid prior to attendance
11. All participants are required to abide by Fowler grounds policy including swimming and boating restrictions, pets (not allowed), bikes (not allowed) and any others required by Fowler Staff.
12. As required by NYSDH regarding H1N1: any camper participant with a fever over 100 degrees will be immediately quarantined and required to be brought home. Unless required Camp Fowler will not refund camp fee under these conditions unless required by NYS to do so. Camp Fowler is in full compliance with all NYS guidelines limiting the spread of H1N1.
13. We do so look forward to welcoming you and your loved ones to Camp Fowler's Family Camp week!
